1. *AKC Match regulations (Ch 4, section 4 & Ch 5, section 4) state: Entries may close at any time prior to match or on the day of the match BUT UNDER NO circumstances may entries be accepted AFTER the specified closing date and time.*
2. All AKC rules and regulations for matches apply. Puppies will not compete with adults except in Brace. No ear racks or tape.
3. Professional Handlers may only handle their own dogs.
4. Champions may not compete in conformation except as part of a Brace or in Junior Showmanship.
5. We understand overnight parking is available thru the Fairgrounds. Please contact them directly for reservations and payment. The phone number is 530-621-5860. Gates close at 11:00 p.m.
6. Please bring adequate shelter in case of inclement weather (for those of you who set up outside)
7. **NO XPEN** set up inside the building.
